From the Knoxville Airport (McGhee Tyson Airport [TYS])

From ALCOA HWY, keep left at the fork and merge onto US-129 N (Go 1.4 miles.)
Continue straight onto US-129 N/Alcoa Hwy for 10.4 miles.
Keep left, follow signs for I-40 W/I-75 S/Nashville/Chattanooga and merge onto I-40 W for 6.8 miles.
Take exit 379A for Gallaher View Road.
Turn right onto North Gallaher View Road NW.
Take the 1st right onto East Walker Springs Lane.
Take the 1st left into 8331 E. Walker Springs Lane.
Suite 402 is in the building on the right (Fifth Third Bank).

From Downtown Knoxville

Follow signs for I-40 W/Nashville and merge onto I-40 W.
Take exit 379A for Gallaher View Rd.
Turn right onto North Gallaher View Rd NW.
Take the 1st right onto East Walker Springs Lane.
Take the 1st left into 8331 E. Walker Springs Lane.
Suite 402 is in the building on the right (Fifth Third Bank).

From Downtown Nashville:

Take I-40 East from downtown (Go approximately 166 miles.)
Take exit 379 for Bridgewater Rd toward Walker Springs Rd/Gallaher View Rd
Slight right toward North Gallaher View Rd NW
Take the 2nd left onto North Gallaher View Rd NW
Take the 1st right onto East Walker Springs Lane.
Take the 1st left into 8331 E. Walker Springs Lane.
Suite 402 is in the building on the right (Fifth Third Bank).

From Downtown Atlanta:

Merge onto I-75 North. Go approximately 190 miles to I-40 E.
Take exit 379 for Bridgewater Rd toward Walker Springs Rd/Gallaher View Rd
Slight right toward North Gallaher View Rd NW
Take the 2nd left onto North Gallaher View Rd NW
Take the 1st right onto East Walker Springs Lane.
Take the 1st left into 8331 E. Walker Springs Lane.
Suite 402 is in the building on the right (Fifth Third Bank).

From Downtown Chattanooga:

Take I-24 East approximately 8.6 miles to I-75 North.
Merge onto I-75 North. (Go approximately 84 miles.)
Take exit 379 for Bridgewater Rd toward Walker Springs Rd/Gallaher View Rd
Slight right toward North Gallaher View Rd NW
Take the 2nd left onto North Gallaher View Rd NW
Take the 1st right onto East Walker Springs Lane.
Take the 1st left into 8331 E. Walker Springs Lane.
Suite 402 is in the building on the right (Fifth Third Bank).
